#### International participation at the Midwinter Meeting

**75** international librarians from 18 countries participated in the 2011 Midwinter in San Diego. IRRT hosted a small-scale cocktail reception to welcome these international librarians and the donors of IRRT Endowment Fund. Many thanks for Roberta Stevens, ALA President, for offering her presidential suites as a host site for this event. The event was well attended by the international guests attending.

## Haiti and Chile Library Relief

At the 2010 Midwinter Meeting, the Council passed the Resolution on Rebuilding Libraries and Archives Damaged or Destroyed by the Earthquake in Haiti. The one-year anniversary of the earthquake is tomorrow, January 12<sup>th</sup>. ALA's relief efforts to date have raised and distributed more than \$25,000 for three libraries in Haiti: the Petit Goave Public Library, the Centre Cultural Pyepoudre Community Library, and the Bibliothèque haïtienne des Pères du Saint-Esprit. Much more is needed, as the cost to just rebuild the Petit Goave Public Library is \$350,000. Therefore, the IRC encourages all ALA members to contribute to contribute to this effort.

On February 27, 2010, one of the most powerful earthquakes in history devastated a large part of Chile. Many libraries have been damaged or destroyed. ALA's Chile Library Relief Fund was established subsequently to help the damaged libraries. So far, \$1,500 has been raised to help relief efforts.

To assist in rebuilding collections in Chile, Reforma is soliciting for Spanish language books which will be sent to Chile after the ALA Annual Conference in New Orleans. The IRC's Americas Committee is planning a program for New Orleans on recovery efforts in Haiti and Chile.

#### **Traditional Cultural Expressions Task Force**

IRC passed a motion to express its gratitude to IRC member Maggie Farrell, and Vivian Pisano; from the Office for Information Technology Policy (OITP) Advisory Committee; for serving as co-chairs and the rest of the task force members for their outstanding work on the final report. And for their efforts in informing the members on the issues, the taskforce has explored. Former IRC member Brad Schaffner for also serving on the Task Force.

#### IFLA Update at the 2011 Midwinter Meeting

Ms. Ingrid Parent, incoming IFLA President, attended the Midwinter Meeting. Ms. Parent gave reports and updates at the IRC meetings and at the IFLA Updates Session. In 2011, she will focus on implications of digitization on user communities; leadership roles from library and information communities to cultivate younger generation of the professionals; outreach and advocacy efforts from library communities; preserve cultural heritages in disastrous areas such as Haiti; multilingual aspect of IFLA publications, and effective and efficient operations of IFLA.

U.S. librarians consist of 19 percent of IFLA members. Ms. Parent praised the contributions from U.S. librarians, which has helped shape the policy development and programs of IFLA.

The 2011 World Library and Information Congress: 77<sup>th</sup> IFLA General Conference and Assembly will be held on August 13-18, 2011, in San Juan, Puerto Rico. Because of the short distance between San Juan to the U.S. continent, Ms. Parent encouraged U.S. librarians to take advantage of this proximity of the conference site to attend this international annual conference.

#### An ALA Representative to the U. S National Commission of UNESCO

In May last year ALA was again invited by the U.S. State Department to be a member of U.S. National Commission of UNESCO. The IRC developed criteria in selecting an ALA representative to the U.S. Commission. A call to serve as the representative to the Commission was sent in December 2010. IRC received a strong pool of nominations. At the IRC Monday meeting, the Committee reviewed all nominations and made recommendations according to criteria. The recommendations will be sent to the Executive Board for an approval.

#### ALA Nominations to IFLA Standing Committees

The year of 2011 is the IFLA election cycle for representatives for 2011-2015. The calls for nominations were sent out to their membership by ALA units in spring 2010. IRC has reviewed all nominations recommended from these units and presented the approved list to the ALA Executive Board for approvals in October and November 2010, and in January 2011 respectively. As of this writing, more than 30 ALA members were recommended to serve on IFLA standing committees.

The IRC would like to thank all the units of ALA for their effort to select highly qualified candidates to represent ALA. A list of the ALA representatives to IFLA Committees is attached to this report, CD 18.1.

#### <u>Guadalajara Book Fair</u>

Led by ALA President Roberta Stevens, 115 ALA members attended the Guadalajara Book Fair at the end of November through the 12<sup>th</sup> year of the ALA-FIL Free Pass Program. Despite the current economic conditions, these librarians continue their efforts to collect valuable materials for their Spanish-speaking communities. President Stevens presented at the annual Coloquio coordinated by the University of Guadalajara. Her presentation, "*Protection of Cultural Works*," drew a packed audience of over 200.

## **Campaign for World's Libraries**

The IRC is pleased to report that two more countries joined the Campaign for the World's Libraries this fall, Barbados and Taiwan. IRO Director Michael Dowling provided presentations on the Campaign at both countries Annual Conference.

A successful program on the Campaign was held at the IFLA Conference in Gothenburg, Sweden last August, with presentations from Jamaica and Zayed University in the United Arab Emirates. At the upcoming IFLA Conference in San Juan, these two new countries will provide presentations on their activities, along with Argentina.

## ALA Advocacy Coordinating Group

Chair Sha Li Zhang joined the ALA Advocacy Coordinating Group to help connect ALA's domestic and international advocacy efforts. She participated in the discussions and action items of the group via conference calls and Midwinter meetings. The Group is also interested in working with IRRT and IRC for an international snapshot day in April each year.

## China-U. S. Collaboration

Chair Sha Li Zhang participated in the China – North American Library Conference, held in Beijing, September 2010. The bilateral conference was organized by the Library of Congress, National Library of China, and Library Society of China, with a theme of Sharing Digital Resources: Challenges and Opportunities. The sub-themes include Resource Sharing Policies and Perspectives, Digital Infrastructure and Repository Technology, Research data Sharing, Sharing Digital Preservation Methods, and Shared Digital Access, Retrieval, and Use. A U.S. delegation of more than 50 librarians and information professionals participated in the Conference. The China-U.S. Librarians Professional Exchange Project, *Think Globally, Act Globally*, received additional funding of \$250,000 from the Institute of Museum and Library Services (IMLS) for extension through August 31, 2011. The project will continue its educational programs between the two countries and concentrate on further development of a web portal of Chinese resources. The granted Project is collaborative efforts among the Chinese American Library Association (CALA), the University of Illinois Urbana Champaign's Mortenson Center, and the Library Society of China. The project promotes the exchange of personnel and information between the library community in China and the United States, and a web portal development on cultural heritages from Suzhou Library and Northeast Normal University Library in China.

## ALA 2015 International Strategic Plan

IRC, IRRT, and other ALA units have begun to develop the new 2015 International Strategic Plan, which will guide international initiatives, programs, and priorities of the Association. A working group was formed at this meeting. The time table is that the final version will be developed by the ALA Annual Conference in June 2011. Input and comments are welcome.

## Preparing International Programming at the Annual

A series of international programs from IRC subcommittees, IRRT, and other ALA units are in planning and will be presented at the Annual Conference in New Orleans. With increased interests in global issues, information sharing, and exchanges from U.S. librarians, these programs and events will be very appealing to all ALA Annual Conference attendees.

## Losses of the international community

The IRC and IRRT shared the sadness with the Council of the passing of Mr. Norman Horrocks, an international advocate and Notable IRRT member. Norman will be missed by all of us.

The ALA international community lost another advocate, Mr. Edward Swanson whose passing also saddened the IFLA community.
