- Whereas, Dr. George P. D'Elia dedicated his life's work to the advancement of library services through research and the education of librarians and library and information studies faculty;
- Whereas, Dr. George P. D'Elia earned his AB in history, his MLS, and his PhD in LIS at Rutgers, The State University of New Jersey and his MS in statistics from Syracuse University;
- Whereas, Dr. George P. D'Elia began his academic career in the School of Information Studies at Syracuse University, then moved to the Library School at the University of Minnesota, where he served as director from 1982-1985, then taught in the Information and Decision Sciences Department of the Carlson School of Management at the University of Minnesota until he moved to the School of Library and Information Studies at the University at Buffalo, State University of New York, as professor and director of CARLIS, the Center for Research in Library and Information Studies;
- Whereas, Dr. George P. D'Elia made many contributions to library education, particularly by teaching courses in research methods, public libraries, and management, by mentoring numerous doctoral students and faculty colleagues, by conducting valuable research in the identification and understanding of the information needs of library users and the design of information systems and services to meet those needs, and by serving as director of the Library School at the University of Minnesota;
- Whereas, Dr. George P. D'Elia was a true scholar and expert researcher having written over 80 papers and reports, including work that won the research paper competition of the Association for Library and Information Science Education in 1990, 1995, and 2001 and the research paper competition of the Library Research Round Table of the American Library Association in 1980, 1982, 1984, an most notably in 2003 with Joseph Woelfel and Corinne Jorgensen for the study of "The Impact of the Internet on Public Library Use" which won the Jesse H. Shera Award for Distinguished Published Research; and
