- Whereas Jack C. Gerts, II, was a devoted and productive staff member at the Headquarters of the American Library Association for most of his adult life from February 1971, until his unexpected death on May 5, 2013, at the age of 59;
- Whereas Jack's work, first in the Distribution Center until 1973, then as Offset Operator until 1984 and as Reprographics Supervisor until his death, spanned technological development unimagined at the time of his initial employment, as well as constantly increasing demands for the expertise and varied skills he had developed, including his skill at working with people encountering deadlines and crises of myriad kinds and complexity;
- Whereas Jack was the leader of a team which annually produced thousands of pages of ALA documents, including numerous drafts, including, for example, a regular production of 200 copies of more than 50 ALA Council documents for each Midwinter Meeting and Annual Conference, in addition to documents for ALA divisions, committees, round tables, and other units of the Association:
- Whereas Jack dealt with that team, as he did with all his many personal connections within and beyond the American Library Association, with respect, interest, and a commitment to quality; and
- Whereas in 1997, Jack was honored with the ALA Staff Achievement Award and in 2012, with recognition of his forty years of devoted and high-quality service to the Association, in addition to numerous notes of appreciation from ALA staff and members: now, therefore, be it
